

MEMORANDUM OF UNDERSTANDING (MoU)

7. DURATION

This MoU shall remain in force for Six (06) Months from the date of signing unless extended by mutual written consent.

8. FINANCIAL PROVISIONS

Each party shall bear its own expenditure unless otherwise agreed in writing.

9. AMENDMENT

Any amendment shall be made only with the mutual written consent of both parties.

10. TERMINATION

Either party may terminate this MoU by giving thirty (30) days' written notice.

11. DISPUTE RESOLUTION

Disputes, if any, shall be resolved amicably through mutual consultation.

12. GENERAL PROVISIONS

This MoU represents the understanding between the parties and does not create any legal or financial liability beyond the agreed activities.
